C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Two features, Swale Complex A and Swale Complex B were identified in the project area.

Swale Complex A does not contain any definable indicators of OHWM. In addition, there is no defined feature or swale located above (southeast) or below (northwest) of the study area where the swale enters and exists the project site study area. Plant cover within Swale Complex A is sparse and is consistent with the species present outside of the swale complex. Despite the lack of an OHWM and hydrophytic vegetation a wetland sample point was taken within Swale A at the lowest point in the topography. The sample point did not meet the hydrology or vegetation parameters, but did meet the hydric soil parameters due to the sample point being located within a low point in the landscape allowing for water to stagnate and pond. Normal conditions are present and the sample point is not considered a wetland as defined in 33 CFR 328.3(b).

Swale Complex B is located along the south side of Jess Martin Park north of Highway 79. Swale B runs parallel to Highway 79 to the south and Jess Martin Park to the north and is best described as a road side ditch. Overland flows from the highway and park to the north and the hills east of the highway are captured in Swale B and conveyed to the northwest corner of Jess Martin Park where it meets Swale Complex A. For the most part Swale Complex B does not contain any definable indicators of OHWM. However, approximately 75 linear feet of Swale B contains slight evidence of an OHWM and bed and bank immediately downstream of a pipe culvert road crossing. The 277 linear feet of Swale B located upstream and the 555 linear feet of Swale B located downstream of the 75-foot area do not contain any indicators of an OHWM or bed and bank. A wetland sample point was taken within Swale B where the marginal indicators of an OHWM were present. The results of the sample point did not indicate the presence of any of the three wetland parameters as required in 33 CFR 328.3(b). Although Swale B contains limited evidence of an OHWM, the feature was determined to not be a potential water of the U.S. because the feature is a road-side and park swale. Based on historical aerial photographs the swale was wholly excavated in the uplands and drains only uplands, does not replace or relocate a waters of the U.S., does not connect a waters of the U.S. to another waters of the U.S. , and does not convey relatively permanent flows to a waters of the U.S. Therefore, Swale B is not considered a potential water of the U.S.

Swale Complex A and B are not considered potential waters of the U.S. as they are shallow features in a relatively flat landscape that lack any physical characteristics such as a clear, natural line impressed on the bank, shelving, changes in the character of soil, destruction of terrestrial vegetation, or the presence of litter or debris. Furthermore, Swale A and Swale B do not support wetlands as none of the wetland sample points indicated that wetland conditions (33 CFR 328.3(b)) were present in the study area. The project area does not support waters of the U.S. as defined in 33 CFR 328.3(a) and therefore is not subject to the Corps geographic jurisdiction.
