SUBJECT: Approved Jurisdictional Determination regarding presence/absence of geographic jurisdiction

Dear Mr. Fouladi:




Figure 1 Regional vicinity of feature evaluated for AJD at 20 Old Ranch Road.




Figure 2 Footprint and immediate vicinity of feature evaluated for AJD at 20 Old Ranch Road.

Reference is made to your request (File No. SPL-2015-00789-ERS) dated October 26, 2015, for an approved Department of the Army jurisdictional determination (JD) for the 20 Old Ranch Road project site, located within the city of Laguna Niguel, Orange County, California (Figures 1 and 2). The drainage feature at this site that was evaluated for this Approved Jurisdictional Determination is approximately 500 linear feet in length and is located within a parcel that is bounded to the west by Old Ranch Road and to the east by Peppertree Bend. The center of the drainage feature lies at coordinates 33.497444, -117.686342.

As you may know, the Corps' evaluation process for determining whether or not a Department of the Army permit is needed involves two tests. If both tests are met, then a permit is required. The first test determines whether or not the proposed project is located in a water of the United States (i.e., it is within the Corps' geographic jurisdiction). The second test determines whether or not the proposed project is a regulated activity under Section 10 of the River and Harbor Act or Section 404 of the Clean Water Act. As part of the evaluation process, pertaining to the first test only, we have made the jurisdictional determination below.

Based on available information, we have determined there are no waters of the United States on the project site, in the locations depicted on the enclosed figures. The basis for our determination can be found in the enclosed JD form.

This letter contains an approved jurisdictional determination for the 20 Old Ranch Road project site. If you object to this decision, you may request an administrative appeal under Corps regulations at 33 CFR Part 331. Enclosed you will find a Notification of Appeal Process (NAP) fact sheet (Appendix A) and Request for Appeal (RFA) form. If you request to appeal this decision you must submit a completed RFA form to the Corps South Pacific Division Office at the following address:

In order for an RFA to be accepted by the Corps, the Corps must determine that it is complete, that it meets the criteria for appeal under 33 C.F.R. Part 331.5, and that it has been received by the Division Office within 60 days of the date on the NAP. Should you decide to submit an RFA form, it must be received at the above address by **January 19, 2016**. It is not necessary to submit an RFA form to the Division office if you do not object to the decision in this letter.

This verification is valid for five years from the date of this letter, unless new information warrants revision of the determination before the expiration date. If you wish to submit new information regarding the approved jurisdictional determination for this site, please submit this information to Eric Sweeney at the letterhead address by **January 19, 2016**. The Corps will consider any new information so submitted and respond within 60 days by either revising the prior determination, if appropriate, or reissuing the prior determination. A revised or reissued jurisdictional determination can be appealed as described above.

This determination has been conducted to identify the extent of the Corps' Clean Water Act jurisdiction on the particular project site identified in your request. This determination may not be valid for the wetland conservation provisions of the Food Security Act of 1985. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should request a certified wetland determination from the local office of the Natural Resources Conservation Service, prior to starting work.

Explain: The feature is a vegetated swale that does not have a discernable ordinary high water mark and does not flow to a downstream Traditionally Navigable Water (TNW). No indicators of an OHWM could be discerned during a field visit to the site on 11/6/15, as shown in Figure 3.

Additionally, hydrologic inputs to the swale are limited to runoff produced by the upslope housing development. The limited hydrology received by the feature was also evident from the complete lack of scour throughout the channel. As shown in Figure 3, vegetation grows abundantly throughout the feature, suggesting that active flows through the feature are very rare.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
