


The parties hereto mutually agree to amend Contract no. **43A0275 TO 001**, dated **May 17, 2010**, and its amendments, as follows:

MOA, Article V, Funding, is amended to now read as follows:

Within thirty (30) days of execution of this MOA, Caltrans shall pay the anticipated costs expected to be incurred through **January 31, 2015** at the level specified in the Corps' budget estimate, which is included as **Appendix C** to this MOA and incorporated herein by reference. Maximum payable under this MOA shall not exceed **\$2,079,685.72**.

MOA, Article XI, Effective Date and Duration, is amended to now read as follows:

This MOA will become effective on the date of the signature by the last Party, and approval by Department of General Services. This MOA shall remain in force until whichever of this events occurs first: 1) **January 31, 2015**, unless the sunset clause of section 214 of WRDA 2000 is extended or section 214 is made permanent, in which case the MOA will remain in effect for the duration of the statutory extension but not to exceed the time period specified in the Standard Agreement, whichever date is earlier; or 2) the MOA is terminated pursuant to **Article X**; or 3) the Standard Agreement expires or terminated pursuant to its terms.

All other terms and conditions of the original Agreement, and its amendments, shall remain in full force and effect.
