If B(7) is used as the Basis of Jurisdiction, document the rationale used to make adjacency determination:* The Land Trust of Santa Barbara County proposes to remove invasive vegetation from 27 sites on lower Refugio Creek near Gaviota. The bulk of the vegetation to be removed is *Arundo donax*, but other species including castor bean and ivy would be removed as well. Hand crews would remove the vegetation and apply herbicide to the cut stumps in densely vegetated areas. Cut vegetation would be removed from the creek by hand and by mechanical winch, as appropriate. Use of the winch to remove vegetation could result in a discharge of native soil by creating small furrows and berms as the material is dragged out of the creek. Cut vegetation would not be discharged into the creek. Refugio Creek is tributary to the Pacific Ocean, a navigable water of the United States subject to the ebb and flow of the tide as described in 33 CFR 328.3(a).
