Cucamonga Creek Channel – Landscaping and Multipurpose Trail

Requester: In compliance with U.S.C. Title 33, Chapter 9, Subchapter 1, Section 408, City of Ontario, through San Bernadino County Flood Control District, has requested permission from the U.S. Army Corps of Engineers (USACE) to alter Cucamonga Creek Channel.

Location:

The proposed action would install landscaping and irrigation system, replace fencing, and slurry seal existing access road for use as a multipurpose trail along Cucamonga Creek Channel in the city of Ontario, San Bernardino County, California. The proposed features are not inside the channel, and will therefore not require construction within the channel.

Requester's Proposed Action:

The City of Ontario is proposing to install landscaping and irrigation system east of the existing access road, replace fencing along the easterly right of way boundary, and asphalt slurry seal an existing access road for use as a multipurpose trail. All staging required for the project will be accomplished on-site within the proposed project limits. No offsite staging will be required to construct these improvements, and would not require access into the channel. The purpose of the project is to provide a multipurpose trail system throughout the city for use by its residents, and is in conformance with the Memorandum of Understanding between SBCFCD and the City of Ontario for the Purpose of Development of a Multiuse Trail System as approved on October 23, 2012.

Authority: The authority to grant permission for temporary or permanent use, occupation or alteration of any USACE Civil Works project is contained in Section 14 of the Rivers and Harbors Act of 1899, as amended, codified at 33 USC 408 ("Section 408"). Section 408 authorizes the Secretary of the Army, on the recommendation of the Chief of Engineers, to grant permission for the alteration or occupation or use of a USACE project if the Secretary determines that the activity will not be injurious to the public interest and will not impair the usefulness of the project. The Secretary of Army's authority under Section 408 has been delegated to the USACE, the Chief of Engineers. The Chief of Engineers has further delegated the authority to the USACE, Directorate of Civil Works and Division and District Engineers, depending upon the nature of the activity.

Limits of Section 408 Authority: A requester has the responsibility to acquire all other permissions or authorizations required by federal, state, and local laws or regulations, including any required permits from the USACE Regulatory Program under Section 10 of the Rivers and Harbors Act of 1899 (33 USC 403), Section 404 of the Clean Water Act (33 USC Section 1344), and/or Section 103 of the Marine Protection, Research and Sanctuaries Act of 1972 (33 USC 1413). In addition, an approval under Section 408 does not grant any property rights or exclusive privileges nor does it authorize any injury to the property or rights of others.

Consideration of Comments: The Corps is soliciting comments from the public, Federal, State and local agencies and officials, and other interested parties. Comments will be made part of the record, and they will be considered before permission is granted to proceed with this action. Please limit comments to the area of the alteration and those adjacent areas that would be directly or indirectly affected by the alteration described in this public notice.

Submission of Comments: Interested parties may submit, in writing, any comments concerning this proposal. Comments should reference public notice no.
