Requester: In compliance with U.S.C. Title 33, Chapter 9, Subchapter 1, Section 408, City of Los Angeles Bureau of Sanitation, through the Los Angeles County Flood Control District (LACFCD), has requested permission from the U.S. Army Corps of Engineers (USACE) to alter the Ballona Creek Channel, Los Angeles County Drainage Area, California.

Location:

The proposed action would install a water quality monitoring station on the bank of Ballona Creek Channel immediate west of the South Fairfax Avenue Bridge in the City of Los Angeles, Los Angeles County, California. The proposed features are not inside the channel, and will therefore not require construction within the channel.

Requester's Proposed Action:

The proposed project involves construction to expand the size of existing concrete pad to accommodate new enclosure of existing autosampler at the same location. Solar panels will be mounted on top of the enclosure, and conduits will be run to the bottom of the channel along the inside of the channel wall.

The purpose of the project is to comply with the Ballona Creek Watershed Coordinated Integrated Monitoring Program as required by the Los Angeles Regional Water Quality Control Board.

Authority: The authority to grant permission for temporary or permanent use, occupation or alteration of any USACE Civil Works project is contained in Section 14 of the Rivers and Harbors Act of 1899, as amended, codified at 33 USC 408 ("Section 408"). Section 408 authorizes the Secretary of the Army, on the recommendation of the Chief of Engineers, to grant permission for the alteration or occupation or use of a USACE project if the Secretary determines that the activity will not be injurious to the public interest and will not impair the usefulness of the project. The Secretary of Army's authority under Section 408 has been delegated to the USACE, the Chief of Engineers. The Chief of Engineers has further delegated the authority to the USACE, Directorate of Civil Works and Division and District Engineers, depending upon the nature of the activity.

Limits of Section 408 Authority: A requester has the responsibility to acquire all other permissions or authorizations required by federal, state, and local laws or regulations,

including any required permits from the USACE Regulatory Program under Section 10 of the Rivers and Harbors Act of 1899 (33 USC 403), Section 404 of the Clean Water Act (33 USC Section 1344), and/or Section 103 of the Marine Protection, Research and Sanctuaries Act of 1972 (33 USC 1413). In addition, an approval under Section 408 does not grant any property rights or exclusive privileges nor does it authorize any injury to the property or rights of others.

Consideration of Comments: The Corps is soliciting comments from the public, Federal, State and local agencies and officials, and other interested parties. Comments will be made part of the record, and they will be considered before permission is granted to proceed with this action. Please limit comments to the area of the alteration and those adjacent areas that would be directly or indirectly affected by the alteration described in this public notice.


