Current and historic aerial photographs show no apparent natural watercourses within the JD Review Area or immediately upstream or downstream from its boundaries. In addition, ground-level photographs show evidence indicative of erosional features including cuts that are often deeper than wide with steep or vertical banks and small beds. These erosional features likely formed due to focused runoff from adjacent development or open space. Soils were reported as being moderate to highly erosive in character, supporting formation of erosive cuts on the property.

Figure 3 identifies the location and extent of all three erosional features based on OHWM indicators documented by AMEC staff. The only OHWM indicators identified in each of the features were a break in bank slope and change in the character of soil. Nevertheless, the hydrogeomorphic character of the features does not indicate they have developed into streambeds. In addition, these features likely only carry water during and immediately after rainfall events. Finally, as shown on Figure 3 and on ground-level photographs, there is a break between the features and the downstream storm drain that eventually leads to Santa Gerturdis Creek. There is little to no evidence of a channel connecting the downstream portions of the erosional features to the storm drain.

In consideration of the information above, relevant JD guidance documents, and best professional judgment, the Corps Regulatory Division has determined the JD Review Area does not contain jurisdictional waters of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
