The Cleghorn Pass Watershed is situated within the closed basin of the Southern Mojave Watershed. Cleghorn Pass and its non-RPW tributaries function as an isolated intrastate system, which lacks the presence of a TNW. Moreover, Cleghorn Pass and all tributaries to Cleghorn Pass are NOT (a)(3) waters as defined by 33 CFR 328.3, as they do NOT meet criteria (a)(3)(i-iii) and since surface waters are

NOT used for industrial or other commercial purposes by interstate commerce industries. Cleghorn Pass is situated within California, San Bernardino County, near Amboy. Cleghorn Pass covers an area exceeding 32,897-acres.

Typical rainfall average in this area ranges from 3- to 5-inches. The groundwater level is near the surface of Cleghorn Pass. Currently, there are no published commercial uses of the surface waters of any tributaries to Cleghorn Pass, and the review of aerial photographs (Google Earth) also did not depict surface water usage of any drainages tributary to Cleghorn Pass. Therefore, all tributaries to Cleghorn Pass are NOT (a)(3) waters as defined by 33 CFR 328.3 (a)(3)(iiii).

Cleghorn Pass, as the terminus for all waters within the Cleghorn Pass Watershed, is NOT a TNW. Moreover, Cleghorn Pass is NOT an (a)(3)water as defined by 33 CFR 328.3. Cleghorn Pass does NOT meet criteria (a)(3)(i-iii), as it: i) DOES NOT have use for surface water recreation or other purposes by foreign or interstate travelers, ii) DOES NOT have harvesting activities of fish or shellfish that may be sold in interstate or foreign commerce, and iii) DOES NOT have surface water industrial usage by industries in interstate commerce. Similar to the tributaries of Cleghorn Pass, there are no published uses of Cleghorn Pass surface waters, mining or otherwise, and there is lack of evidence of any commerce/commercial activity within Cleghorn Pass based on the review of aerial photographs (Google Earth). Cleghorn Pass has been determined to be an intrastate isolated water without a surface water connection to commerce, all tributaries to Cleghorn Pass as part of the overall watershed system are also isolated and additionally have no nexus to commerce. Thus, the Cleghorn Pass Watershed is an isolated watershed system that has no surface water connection to commerce.

Based on the information above, the Corps concludes that all tributaries to Cleghorn Pass are NONJURISDICTIONAL waters of the United States, since the waters are NOT tributary to either a TNW or an (a)(3) water and are NOT (a)(3) waters themselves.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to transfer nutrients and organic carbon that support downstream foodwebs?
- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
