Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

Two existing 90-lf x 90-lf fire suppression ponds are located within the area known as the object free area (OF A) at Chino Airport. These two ponds were constructed in 1986 to supply water to a fire suppression system for facilities on the southeast corner of the airport. Based upon a review of historic aerial photographs, the basins were constructed in the uplands within an agriculture field, outside any potential waters of the United States. Furthermore, the fire suppression ponds are holding ponds only, and they have no surface connection to any other water body. Finally, the ponds also do not have a connection to groundwater, as the ponds are lined with synthetic material to prevent any water loss due to infiltration. As noted in the Federal Register, Volume 51, Number 219, Page 41217, November 13, 1986, pursuant to 33 CFR Section 328.3(c), "(c) Artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing," are not considered waters of the United States pursuant to Section 404 of the Clean Water Act. Therefore, as the ponds were constructed in uplands and do not have any surface or subsurface connection with other waters, these waters are not regulated waters of the United States under the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.





The ponds appear in the 2005 aerial photo. According to San Bernardino County Department of Airports, the 90-feet x 90 feet fire suppression ponds were built in 1986. Furthermore, the ponds are lined with synthetic material to prevent loss from infiltration.
