Explain: **The project area consists of a connected series of 3 basins (Basins 2-4) originally designed for groundwater recharge/infiltration, as well as three non-RPW drainages (Drainages 1-3) tributary to the basins and Drainages 2 and 3 associated wetland areas; all intrastate waters. The total acreage of the project waters are as follows: Basin 2 (5.69 acres), Basin 3 (10.2 acres), Basin 4 (14.64 acres), Drainage 1 (0.15 acre), Drainage 2 (0.004 acre), Drainage 3 (0.06 acre), Drainage 2 adjacent and in-stream wetland (0.066 acre), and Drainage 3 in-stream wetland (0.04 acre) (see**

Exhibit 9). The original purpose of the basins was to redirect flows from the adjacent concrete-lined Warm Creek Channel into the basins for water conservation (ground water recharge). Per the original basins design function, flows entered the basin system through a flow diversion gate in the northern most basin, flowing south and spreading through each basin before outflowing through a flow control box structure at the south end of the southern-most basin (Basin 4). Because of the proximity to groundwater, the recharge within the basins was not practicable, and thereby in-flows from Warm Creek Channel were permanently closed off.

Since 1982, the Basins have been used as a part of storm-drain infiltration system receiving urban runoff from adjacent streets and development. The storm drain system includes inflow pipes and culverts at four different locations (see Exhibit 9). Historically, given the large original design size of the basins for intercepting flows from the large drainage area of Warm Creek, the total storm runoff volumes received from four immediate small basin drainage areas were insufficient to result in discharge from the basins system to Warm Creek Channel (see Exhibit 5) through the Basin 4 box outlet. Also, runoff entering Basin 4 would not result in a discharge of flows from Basin 4 to Warm Creek for even a 100-year event, through physical bank over-topping of Basin 4. Furthermore, the box outlet structure in Basin 4 was permanently closed and disabled (control cables removed, welded shut, and paint sealed) several years ago. As such, Basins 2-4, Drainages 1-3 and Drainages 2-3 wetland areas have no downstream surface connection to Warm Creek Channel.

These project waters have no downstream connectivity to a TNW, and they have no nexus to interstate or foreign commerce. The project waters are not (a)(3) waters as defined by 33 CFR 328.3, and these waters do not meet any of the i-iii criteria (no surface water recreation or interstate commerce related to fisheries or industry).

Based on the above information, the Corps concludes that these 30.74 acres of non-RPW and 0.106 acre of associated non-RPW wetlands are NOT jurisdictional waters of the United States, since the non-RPWs and wetlands have no commerce connection, are NOT (a)(3) waters as defined by 33 CFR 328.3, and are isolated with no connection to a downstream TNW.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
