Explain: **The unnamed wash, also known as 'Desert Center Wash', is a non-RPW that drains to Ford Dry Lake located approximately 23 stream miles to the east of where the wash crosses the Interstate 10 (I-10) freeway. The wash has no connection to a TNW. The Desert Center Wash sub-watershed upstream of the I-10 freeway consists of runoff from**

the north facing slopes of the Chuckwalla Mountains and west facing slopes of the Alligator Mountains. The watershed of the Ford Dry lake is approximately 4,000 square miles and includes several valleys and basins. The Desert Center Wash is tributary to the Chuckwalla Valley Wash which drains to Palen Dry Lake then to Ford Dry Lake. Desert Center Wash and Ford Dry Lake are intermittent to ephemeral and do not support water-based commerce. No commerce related to surface-waters on the Ford Dry Lake exists, as the lake is dry most of the year. The Desert Center Wash within the project study area contains sandy soils with sparse vegetation. No wetlands or wetland vegetation occur in this portion of the wash. Water is only present in the unnamed wash during or immediately after heavy rain events. The Desert Center Wash within the project area does not meet the criteria for jurisdictional Waters of the U.S.; therefore, Desert Center Wash is non-jurisdictional under SWANCC.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The unnamed wash, also known as 'Desert Center Wash', is a non-RPW that drains to Ford Dry Lake located approximately 23 stream miles to the east of where the wash crosses the Interstate 10 freeway. The wash has no

connection to a TNW. The Desert Center Wash sub-watershed consists of runoff from the north facing slopes of the Chuckwalla Mountains and west facing slopes of the Alligator Mountains. The watershed of the Ford Dry lake is approximately 4,000 square miles and includes several valleys and basins. The mean annual precipitation in the region is 4 inches. The dry lake and the washes that drain to the dry lake are intermittent to ephemeral and do not support water-based commerce. There are some unconfirmed social media references to impromptu fishing and photos of fish remnants within Ford Dry Lake; however, the fish may have been introduced and fishing is not conducted on a regular basis that would support regular water-based recreational uses or commerce. Non surface water related recreational uses, including off-highway vehicle (OHV) operation, rockhounding, and wildlife watching, occur in the vicinity of the washes and dry lake including the uplands. No commerce related to surface-waters on the dry lake exists, as the lake is dry most of the year. The Ford Dry Lake, as the terminus of the Desert Center Wash, is NOT an (a)(3) water as defined by 33 C.F.R. 328.3. The Ford Dry Lake does NOT meet criteria (a)(3) (i-iii), as it: i) does NOT have use for surface water recreation or other purposes by foreign commerce, and ii) does NOT have harvesting activities of fish or shell fish that may be sold in interstate or foreign commerce, and iii) does NOT have surface water industrial usage by industries in interstate commerce. Lastly, Desert Center Wash is NOT an (a)(3) water defined by 33 C.F.R. section 328.3. The Desert Center wash within the project area contains sandy soils with sparse vegetation. No wetlands or wetland vegetation occur in the wash. Scientific research (Edmund C. Jaeger Nature Sanctuary) and granite mining occurs near the headwaters; however, the activity is non-surface water related. Water is only present in the wash during or immediately after heavy rain events. In addition, Ford Dry Lake and Desert Center Wash do not cross state boundaries. Therefore, since Ford Dry Lake is an intrastate, isolated water without surface water connection to commerce, Desert Center Wash, as part of the overall watershed system is also isolated and additionally has no nexus to commerce. Based on the above information, the Corps concludes that Desert Center Wash (isolated non-RPW) is a NON-JURISDICTIONAL aquatic resource, since the water is NOT tributary to either a TNW or an (a)(3) water and is NOT an (a)(3) water itself. The Corps has made such a conclusion since the water is tributary to an isolated, intrastate dry lake. The Corps also references Approved Jurisdictional Determination SPL-2010-00095-JEM which determined that Ford Dry Lake was non-jurisdictional isolated waters.
