Explain: **The ephemeral unnamed wash, also known as 'Isora Ditch', is a non-RPW that drains to an unnamed dry lake located approximately 2.5 miles to the southwest of the where the wash crosses the Interstate 10 freeway. The wash has no connection to a TNW. The unnamed dry lake watershed consists of runoff from the south facing slopes of the**

**MCCO Mountain range and parts of the western facing slopes of the Mule Mountain range. The watershed of the dry lake is approximately 72.7 square kilometers. The dry lake and the washes that drain to the dry lake are ephemeral and do not support surface water-based commerce. No commerce related to surface-waters on the dry lake exists, as the lake is dry most of the year. The Isora Ditch wash within the project area contains sandy soils with sparse vegetation. No wetlands or wetland vegetation occur in the wash. Water is only present in the wash during or immediately after heavy rain events. The Isora Ditch within the project area does not meet the criteria for jurisdictional Waters of the U.S.; therefore, Isora Ditch is non-jurisdictional under SWANCC.**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD:** The ephemeral unnamed wash, also known as 'Isora Ditch', is a non-RPW that drains to an unnamed dry lake located approximately 2.5 miles to the southwest of the where the wash crosses the Interstate 10 freeway. The wash has no connection to a TNW. The watershed of the unnamed dry lake consists of runoff from the south facing slopes of the Mc Coy Mountain range and parts of the western facing slopes of the Mule Mountain range. The watershed of the dry lake is approximately 72.7

square kilometers. The mean annual precipitation in the region is 4 inches. The dry lake and the washes that drain to the dry lake are ephemeral and do not support surface water-based commerce. Non surface water related recreational uses, including off-highway vehicle (OHV) operation, rockhounding, and wildlife watching, occur in the vicinity of the washes and dry lake including the uplands. No commerce related to surface-waters on the dry lake exists, as the lake is dry most of the year. The unnamed dry lake, as the terminus of the Isora Ditch, is NOT an (a)(3) water as defined by 33 C.F.R. 328.3. The unnamed dry lake does NOT meet criteria (a)(3) (i-iii), as it: i) does NOT have use for surface water recreation or other purposes by foreign commerce, and ii) does NOT have harvesting activities of fish or shell fish that may be sold in interstate or foreign commerce, and iii) does NOT have surface water industrial usage by industries in interstate commerce. Lastly, Isora Ditch is NOT an (a)(3) water defined by 33 C.F.R. section 328.3. The Isora Ditch wash within the project area contains sandy soils with sparse vegetation. No wetlands or wetland vegetation occur in the wash. Water is only present in the wash during or immediately after heavy rain events. In addition, Isora Ditch and the unnamed dry lake do not cross interstate boundaries. Therefore, since the unnamed dry lake is an intrastate, isolated water without surface water connection to commerce, Isora Ditch as part of the overall watershed system is also isolated and additionally has no nexus to commerce. Based on the above information, the Corps concludes that Isora Ditch (isolated non-RPW) is a NON-JURISDICTIONAL aquatic resource, since the water is NOT tributary to either a TNW or an (a)(3) water and is NOT an (a)(3) water itself. The Corps has made such a conclusion since the water is tributary to an isolated, intrastate dry lake.
