## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). B. ADDITIONAL COMMENTS TO SUPPORT JD: The areas under examination do not contain bed/bank ephemeral channels that typically are present along jurisdictional watercourses thoughout Pima County. Ground elevations between upgradient and downgradient areas are indestinguishable having as little as 0.1 foot of elevation change. Stormater runoff throughout the area occurs as overland sheet flow and the locations of higher density vegetation are erosional features where entrained sediments have accumulated due to deposition. Adjacent property located upgradient of the project site was determined under ACOE File #2008-00016-MB.
