C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: A previous approved jurisdictional determination was issued by this office on September 18, 2007, finding that the 1520 Gleneyre property consisted entirely of uplands. According to information provided by the applicant, this condition has not changed and the proposed project would not result in a discharge of dredged or fill material into waters of the

United States. Bluebird Canyon Creek flows into an unground culvert on an adjacent parcel and flows underneath a portion of the 1520 Gleneyre property. This creek is entirely underground through the property boundaries; therefore, no ordinary high water mark exists on the property. In addition, no wetlands are present on the property. It should be noted that if Bluebird Canyon Creek is daylighted on the 1520 Gleneyre property in the future, this approved jurisdictional determination would no longer be considered valid.
