Ridgecrest is located in the Southern portion of Indian Wells Valley. The study area contains two drainage features and one detention basin: "South College Heights Desert Wash" (CHW-14 and CHW-16), "East Bowman Desert Wash" (BW-11), and "West Detention Basin" (BW-09). The average annual precipitation in the valley is about 4 to 6 inches. Flows from these project waters would generally flow northeast, with flows normally terminating in desert washes on the project site. Indian Wells Valley is a closed, internally drained basin bounded by an outcrop of igneous and metamorphic basement rock complexes. The project site slopes gradually downward from south to north; ranging in elevation from 2260 to 2281 feet above mean sea level. Prior to reaching their ultimate terminus in China Dry Lake, flows would likely pass through either Mirror Dry Lake or Satellite Dry Lake. China Dry Lake, at 2,150 feet above mean sea level, is the point of lowest elevation in the Indian Wells Valley watershed, in which the three project drainage features are located. Therefore, the ultimate downstream hydrological terminus of the project waters is China Dry Lake, an intrastate dry lake. China Dry Lake is located approximately 7 miles northeast of the project site. Currently, there are no published commercial uses of the three project drainage features or China Dry Lake. Historically gypsum, table salt, talc, potash, and soda ash were profitably mined from the China Dry Lake area.

China Dry Lake, as the terminus for the project water, is NOT a TNW. Moreover, China Dry Lake is NOT an (a)(3) water as defined by 33 CFR 328.3. China Dry Lake does NOT meet criteria (a)(3)(i-iii), as it: i) DOES NOT have use for surface water recreation or other purposes by foreign or interstate travelers, ii) DOES NOT have harvesting activities of fish or shellfish that may be sold in interstate or foreign commerce, and iii) DOES NOT have surface water industrial usage by industries in interstate commerce. Lastly, the project water is NOT (a)(3) waters as defined by 33 CFR 328.3. The above is based upon excerpts of the project Jurisdictional Determination (received September 2014, prepared by Cal Ecology on behalf of the applicant), USGS NHD data, and the review of aerial photographs (Google Earth) that also did not show surface water usage of the project waters or the dry lake terminus. Therefore, since China Dry Lake is intrastate isolated water without a surface water connection to commerce, the project water as part of the overall Indian Wells Valley watershed system is also isolated and additionally has no nexus to commerce.

Based on the above information, the Corps concludes the project waters designated as "South College Heights Desert Wash", "East Bowman Desert Wash", and "West Detention Basin" are non-jurisdictional aquatic features since they are not tributary to either a TNW or an (a)(3) water and are not (a)(3) waters themselves. The Corps makes such a conclusion since the water is tributary to an isolated dry lake that does not qualify as a TNW or as an (a)(3) water, and since the aquatic features also do not qualify as (a)(3) waters.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
