measured within the project area. This non-RPW is tributary to Clipper Wash which flows into Schulyer Wash and ultimately into Cadiz Lake. The Callumet Mountains, the Ship Mountains, the Granite Mountains/Kilbeck Hills, and the Coxcomb Mountains are situated west, north, east and south, respectively, of both the non-RPW and Cadiz Lake.

This non-RPW is situated within the Cadiz Valley groundwater basin, where any surface flows would travel in a general southward direction, for an approximate distance of 25-miles from the project area to reach Cadiz Lake. As with other non-RPWs in this watershed, this non-RPW usually convey flows in response to major storm events, with an estimated 2-5 flow events per year. Typical area rainfall averages 3- to 5-inches in this area. Cadiz Lake is the terminus for this non-RPW water, as well as for other non-RPWs within the Cadiz Valley groundwater basin. The soils in this area are generally characterized by high rates of permeability. Nonetheless, based on examination of aerial photographs, this non-RPW has both physical surface channel connectivity and hydrologic connectivity with Cadiz Lake. Cadiz Lake, as the terminus for this and other non-RPW waters, is NOT a TNW. Moreover, Cadiz Lake is NOT an (a)(3) water as defined by 33 CFR 328.3. Per Corps headquarters guidance, Cadiz Lake does NOT meet criteria (a)(3)(i-iii), since the Clean Water Act is a surface water law, and in this instance the mining industry located on Cadiz Lake does not directly utilize the lake surface waters. There is no surface-water based commerce associated with the subject drainage based on review of aerial photographs showing no visual sign of water-dependent industry, and lack of water for most of year in the drainage. Therefore, as Cadiz Lake is an isolated water without a surface water connection to commerce, this non-RPW as part of the overall watershed system is also isolated and itself has no appropriate nexus to commerce. Past approved JDs within the Southern Mojave Watershed, specifically for tributaries flowing into Cadiz Lake include files SPL-2012-00806-BLR and SPL-2008-00402-SLP. SPL-2008-00402-SLP determined that Cadiz Lake is a nonjurisdictional water of the United States, since the dry lake is isolated without a surface water connection to interstate commerce. SPL-2012-00806-BLR determined Watson Wash, which flows into Clipper wash, Shulyer wash and then into Cadiz Lake, was not a water of the United States. These projects required approved JDs with a SWANCC determination for tributaries flowing into Cadiz Lake, in close proximity to the Blind Hills proposed project site. In all cases, the waters in question were determined to be unregulated waters of the U.S. Based on the above information, the Corps concludes that this non-RPW is a NON-JURISDICTIONAL water of the United States, since the non-RPW is NOT tributary to either a TNW or an (a)(3) water. The Corps makes such a conclusion since the non-RPW is a tributary to an isolated lake that does not qualify as an (a)(3) water..

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The unnamed ephemeral Subject Tributary flows relatively straight in a confined channel, and is tributary to Clipper Wash, which flows into Schulyer Wash and ultimately into Cadiz Lake (dry). Flow events occur 2-5 times per year and occur most often in the late-summer thunder storm season of August and September as well in the mid-winter months of December through March (references: California State University Desert Studies Center Website Located at <http://biology.fullerton.edu/dsc/school/climate.html> and NOAA at <http://www.wrh.noaa.gov/vef/regionalclimate.php>). At an elevation of 165 meters, Cadiz Lake is the lower of two playas in the Bristol-Danby Trough that have completely separate internal drainage (reference: <http://www.schweich.com/geoCASBrCadizLk.html>). No surface connection exists between Cadiz Lake and the Colorado River, based on available records or hydrology studies. The Subject Tributary and Cadiz lake are located within the Lower Mojave watershed (HUC # 18100100). The Lower Mojave Watershed is an isolated desert watershed (closed basin) (reference: USGS, Water-Supply Paper 2294). The Subject Tributary is not part of the Colorado River watershed, and is within a different hydrologic region (California Region - Region 18). No surface-water based commerce exists for either the unnamed ephemeral Subject Tributary or for the Cadiz dry lake terminus.
