### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

## **B. ADDITIONAL COMMENTS TO SUPPORT JD:**

This JD pertains to the six non-RPW project waters and one associated small wetland (Drainages A, B-1, B-2, C, D, E, and Drainage C Wetland) that ultimately drain from the project site in a north/northwestern direction to Rabbit dry lake. The project is generally located on the north side of the San Bernardino Mountains within the Lucerne Valley, within the HUC 10 Silver Creek-Rabbit Lake subwatershed.

All project Drainages have been defined as ephemeral washes, with a total combined length of 6,469 linear feet and a total combined acreage of approximately 1.35 acres. The single identified wetland area within Drainage C consists of 0.003 acre. The project site is within the Southern Mojave watershed and ultimately drains 5.5-miles north/northwest to Rabbit dry lake. Rabbit dry lake is an intrastate dry lake. The non-RPWs typically convey flows in response to major storm events, with typical annual rainfall totals averaging 6- to 8-inches in the area. Rabbit dry lake is the elevational low point for the project drainages that fall within this local area of Southern Mojave watershed, serving as the terminus for Drainages A, B-1, B-2, C, D, E and Drainage C Wetland, as well as for all other waters within this isolated intermontane basin. All surface flows that enter Rabbit dry lake percolate into the groundwater table. Surface waters for this Rabbit dry lake system are isolated from the Mojave River (located 13-aerial miles further to the west) by the Granite Mountains that surround the dry lake on its west, north and eastern boundaries.

Rabbit Lake, as the terminus for the seven subject project waters, is NOT a TNW. Moreover, Rabbit Lake is NOT an (a)(3) water as defined by 33 CFR 328.3. Rabbit Lake does NOT meet criteria (a)(3)(i-iii), as it: i) DOES NOT have use for surface water recreation or other purposes by foreign or interstate travelers, ii) DOES NOT have harvesting activities of fish or shellfish that may be sold in interstate or foreign commerce, and iii) DOES NOT have surface water industrial usage by industries in interstate commerce. Lastly, Drainages A, B-1, B-2, C, D, E and Drainage C Wetland themselves are NOT (a)(3) waters as defined by 33 CFR 328.3. The above is based upon the JD Report ("Jurisdictional Delineation of Wetlands/Waters Subject to Regulatory Authority: White Know-White Ridge Quarry, Lucerne Valley, California", dated November 2013, prepared by Tetra Tech), the USGS 7.5' topographic quadrangle, Bulter Peak, CA, California, the Lucerne Valley Groundwater Basin: California Groundwater Bulletin #118, the Mojave Water Agency Maps, Este Hydrologic Atlas, Mojave Water Agency, and the review of aerial photographs (Google Earth) that also did not show surface water usage of the project drainages or dry lakes. Therefore, since Rabbit Lake is an isolated intrastate water without a surface water connection to commerce, these seven project waters as part of these overall watershed systems are also isolated and additionally have no nexus to commerce.

Based on the above information, the Corps concludes that Drainages A, B-1, B-2, C, D, E and Drainage C Wetland (isolated non-RPWs, with an associated isolated wetland) are NONJURISDICTIONAL waters of the United States, since the waters are NOT tributary to either a TNW or an (a)(3) water and are NOT (a)(3) waters themselves. The Corps makes such a conclusion since the waters are tributary to an intrastate, isolated dry lake that does not qualify as a TNW or as an (a)(3) water, and since the project waters themselves also do not qualify as (a)(3) waters.
