II. Announcements:

- a. Marina del Rey: Started April 5, 270,000 CY dredged to date.
- b. Lower Newport Bay: Started May 2, 30,000 CY dredged to date.
- c. **Oceanside**: Started May 2, City has asked Corps to place material in front of lifeguard station (approx. 110,000 CY out of total 220,000 CY expected). Final SAPR for Oceanside available.

III. Project Review and Determinations

- a. Channel Islands chemistry data spreadsheet:
 - i. Corps: Only exceedance was for DDE (exceeded ERL, especially area 3)
 - ii. EPA comments (POC: Allan Ota): total DDT needs to be added. Larry Smith agreed it would be in SAPR.
- b. Corps maintenance dredging projects spreadsheet was discussed.
- c. Harborlight Marina: SAPR/Suitability:
 - i. Corps comments (POC: Dan Swenson):

- 1. Design depth seems to be -10 ft MLLW based on Corps RGP:
- 2. This project would be authorized by the Corps under RGP 30;
- 3. Chlordane exceeded ERM in composite sample
- 4. Zinc exceeded ERM for z-layer sample #2, possibly due to discarded batteries:
- 5. Given material to be placed in POLB Middle Harbor, no further testing required.
- 6. Schedule according to applicant: start date in mid-June with expected completion date at end of June.

ii. Agency consensus (RWQCB-LA, Coastal Commission, EPA):

1. No further testing required, but next round of testing should include more detailed z-layer testing.

IV. Other issues:

a. Possibility of joint SC-DMMT/CSMW meeting (POCs: Susie Ming and Dan Swenson):

- i. Coastal Sediment Management Workgroup (http://dbw.ca.gov/csmw/default.aspx) is a multiagency group that generally meets the same day as SC-DMMT.

 - 2. Tijuana Estuary fate and transport demonstration project;
